WITNESS STATEMENT

I remember that I decided to make my way towards Kirkcaldy Health Clinic/Hospital to see if I could. This took me along Templehall Avenue, Kirkcaldy. As I was driving along this road, heading towards the roundabout adjacent to Hayfield Road, Kirkcaldy, I observed a male I would describe as follows: dark coloured skin, muscular build, about 6' in height, wearing a white t-shirt and dark coloured jeans and shoes/trainers. In addition I could see that he was carrying what I believed to have been a kitchen knife in his right hand. The knife itself was about 8" in length, the blade being 6" at most.

This male had his back to me and was walking along this road in the same direction as I was driving. From what I could see he did not appear to be having any difficulty in walking, his arms appeared to be swinging at his sides and he looked to be walking with purpose. I remember noting that it was raining at this time and he looked to be soaking wet.

As I drove past him, I was concerned as to what he was doing with the knife so I removed my phone, using the hands free option, and contacted Police Scotland via the 101 number. I managed to pass all details of what I had observed to the call handler just as I got cut off.
