On Sunday 3rd May I was working with Geoff Levy who [REDACTED].

I was driving that morning and Geoff was the passenger.

I was driving our unmarked Mercedes Sprinter van which is white in colour registration [REDACTED].

[REDACTED] My first drop-off point was at [REDACTED] Birnam Road in Kirkcaldy. That was about 7am and when I got there the shop was not open.

WITNESS STATEMENT

I decided to go to our second drop-off which was on Lauder Road, Kirkcaldy.

This was a Co-op shop near to the Victoria Infirmary.

I remember driving down a main road and turned left into the long road that would take me to the hospital area. It was a mini roundabout I turned left at to go along this road. I don't know the name of this road but it will be recorded on the van's CCTV. This CCTV is transmitted direct to our office and is downloaded there.

I think I was about a quarter of a mile down that road, the hospital would be in front of me.

There were houses on my right and a grassed area to my left with houses beyond this grassed area.

This was about 7.05 - 7.10 am when a dark coloured hatchback, possibly a Vauxhall Corsa was driving slowly towards me. The driver was waving his hand out his window and I pulled up alongside him.

The driver of this car was male, late 20s, ear length dark hair, round face. I couldn't see anybody else in this car.

I have no control over my windows so this guy had to shout to me. I made out that he was saying that there was a guy further up the road with a knife. He suggested that I turn around.

There were 3 or 4 cars now queued up behind me and this guy then drove slowly by me and I think he stopped at every car behind me to tell or warn the drivers.

I drove forward slightly and did a u-turn. At this time I saw a black man, african origin, muscular, mid 30s wearing a white t-shirt and denim trousers. He was between 80-100 yards further down the road. He was on the left side of the road and was walking towards me.

I could clearly see he had a bladed weapon in his left hand. He had both hands out, and it appeared to me that he was on a mission and he was going to take somebody out. His eyes were really wide, and I know he was 80 yards away but I could clearly see that.

He was composed walking at a steady pace, I never saw him run at all.

There were no other moving cars or members of the public in his vicinity that I saw. I turned about and took a left and another left and my sat nav took me another direction to Lauder Road.

As I was approaching Lauder Road I saw a police van with its blue lights and sirens on just a couple of streets away from Lauder Road. This was closely followed by an ambulance which had its blue lights.

The ambulance actually went in the opposite direction from the police van which was going in the general direction of the black guy with the knife.

I would describe the knife as being a bayonet style knife, long thin black maybe about 8 inches long and 1 inch wide, quite thin.

My general impression from the guy's appearance was that he was spaced out on drink or drugs.

I am now handing over my original operational statement which I completed on Monday 4 May before I went out the office. That was about 0610 am.

I have signed a documentary backing sheet.


