STATEMENT

I HAVE BEEN ASKED TO GIVE A STATEMENT TO THE POLICE INVESTIGATIONS AND REVIEW COMMISSIONER. I HAVE BEEN INFORMED OF THE ROLE OF PIRC AND WHY THEY HAVE BECOME INVOLVED IN THIS INVESTIGATION. I HAVE EXPLAINED THAT I WAS ON DUTY ON THE MORNING OF 3RD MAY AT VICTORIA STATION AT 0730 HRS. I HAVE ALSO EXPLAINED THAT I WAS INVOLVED IN THE MEDICAL INTERVIEW OF A CASUALTY WHICH MAY HAVE A CONNECTION TO THIS INCIDENT. I HAVE KNOWLEDGE OF THE MEDICAL INTERVIEW BUT HAVE AGREED WITH PIRC OFFICERS THAT I WILL GIVE A FURTHER STATEMENT OF MY INVOLVEMENT WITH REFERENCE TO DOCUMENTATION AT MY PLACE OF WORK. AT THIS TIME I WILL PROVIDE A STATEMENT OF MY OBSERVATIONS DURING MY COMMUTE TO WORK ON THE MORNING OF THE 3RD MAY 2015. I LEFT FOR WORK AT 07:10 DRIVING A SILVER PUGEO 208 [REDACTED] PROCEEDED TO BURNHAM ROAD ONTO FAIR ISLE RD. AT THE END OF

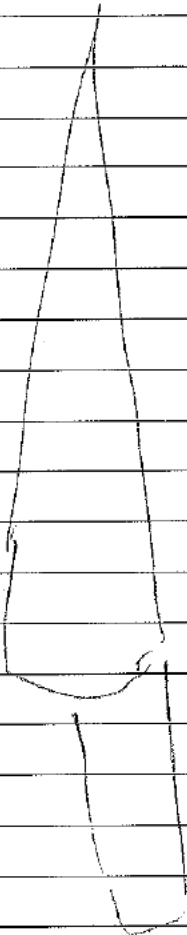

FARISLE RD I TURNED LEFT ON TO TONGUESTAN AVENUE, AT THE END OF TONGUESTAN AVENUE TURN RIGHT AT THE ROUNDABOUT ON TO HENRY ROAD. I SLOWED AT THE MINI ROUNDABOUT TO TURN ON TO HAYFIELD RD AND I OBSERVED A MALE WHO WAS BLACK. I THOUGHT HE WAS IN HIS 20S, AND HE WAS WEARING A WHITE TEE WITH WRITING AND ~~BLACK~~ JEANS. HE WAS ON THE ROAD TAKING A POSITION AT THE CORNER OF THE ROAD WALKING TOWARDS ME. I STOPPED BECAUSE HE WAS IN MY WAY. I THEN SAW HIM WITH A KNIFE, I THINK IT WAS IN HIS RIGHT HAND. THE BLADE WAS APPROXIMATELY 20 CM LONG. I MADE AN ATTEMPT TO ENSURE MY DOOR WAS LOCKED. I THEN DROVE AWAY OVER THE MINI ROUNDABOUT AND STOPPED JUST BEFORE THE NEXT ROAD TO THE LEFT AND LOOKED IN MY REAR VIEW MIRROR APPROXIMATELY SIX HOUSE BLOCKS AWAY AND STOPPED TO PHONE 999 TO REPORT THIS INCIDENT. AS I LOOKED BACK I SAW ~~A~~ A WHITE TAXI WITH THE TAXI NUMBER ON TOP. THE TAXI DROVE OVER THE MINI ROUNDABOUT AND CAME DOWN HENRY ROAD. I WANTED TO BE SURE HE WAS NOT FOLLOWING ME. I TOLD THE CALL HANDLER FOR 999 THAT THERE WAS A MAN ON HAYFIELD ROAD WITH A KNIFE AND I WAS ASKED FOR A DESCRIPTION WHICH I GAVE. HE WAS WEARING A WHITE TEE SHIRT AND HE WAS BLACK. I THEN WENT THROUGH THE HOUSING SCHEME PASSING THROUGH HAZEL ROAD AVENUE, WILSON AVENUE TO LAUREL RD. I WAS GIVEN MY BRIEFING AND WENT TO RESUS. I WAS THEN INFORMED OF A STANDBY FOR A CARDIAC ARREST WHICH CONCERNS ME AS I THOUGHT THE MAN I ~~HAD~~ MAY HAVE OBSERVED WITH THE KNIFE ~~HAD~~ DONE SOMETHING TO SOMEONE ELSE AS I WAS COMING FROM HAYFIELD RD. I OBSERVED THE MAN WHO CAME IN SURVIVING FROM A CARDIAC ARREST AND IDENTIFIED HIM AS THE MAN I HAD SAW EARLIER CARRYING THE KNIFE. I HAVE GIVEN A SKETCH OF THE KNIFE TO ASSIST IN IDENTIFICATION
