I am Kevin Nelson, I currently reside at the aforementioned address with . I have stayed here for about 1 year.

Further to my statement to PIRC dated Tuesday 5 May 2015.

Previously I disclosed to PIRC the events that I witnessed during the morning of Sunday 3 May 2015, on the road (Hayfield) outside the front of my house. These

events involved members of Police Scotland, specifically police officers dressed in uniform and a black male, who I now know to be Sheku Bayoh.

Just after 1800 hours on Monday 24 August 2015, I was at my home with at this time was out of the family home at the gym. I remember hearing the sound of the door bell ringing. As I answered the door, I observed a man I would describe as black, reasonably built, just under 6 foot in height. I noticed he had what I could see as facial stubble. I did not notice any glasses. He was wearing a hat, I would describe it as a bunnet, it was like a knitted baseball cap and either dark blue or black in colour. He had a bulky kacki coloured jacket on and I believe a pair of jeans, the colour I do not remember. I recognised this man from having previously been present on Hayfield Road. I can not remember exactly where. I had however, never had any interaction with this man before. My initial thought was that this man was a friend or relative of Sheku Bayoh. I thought this as had previously told me that a black man had been at the door of our neighbour Ashley Wyse, who lives at Ash ey Wyse address at Hayfield Road, which is upstairs from my house.

I immediately noticed that he was carrying what appeared to be a pile (couple of inches thick) of leaflets in his hands.

I remember that he offered me his right hand to shake and introduced himself. I can not remember what he said his name was. I did not offer my name in turn, however, I did shake his hand. He appeared calm and friendly at no point did I feel intimidated by this man.

I remember him telling me that he was the brother for Sheku Bayoh. I also remember him talking about their mother.

When he first started talking, he was talking really fast, I don't know if this was because he was nervous or if he was upset but the more he talked the calmer he seemed. He told me that he and his family were trying to find out what happened, I remember him saying that they had been told many lies, some of these lies included that his brother was found across the road next to the power sub station. He then said they'd also been told a passer by had found him on the street.

He then started to talk about having seen a photographic still from around this area. I understood this to mean from around the area of my house. I remember him pointing to Ashley's gate. He went on to say that the still appeared to be from the angle of looking downwards and that it had shown his brother with police officers around him. He said that the still must have come from this block (I live in a block of four). He then implied that the still was from one of the upstairs flats.

I felt that this man was trying to get information from me (fishing for information) as if he was expecting me to agree with him and provide him with information regarding my knowledge of this photographic still.

From what I remember he kept repeating the same thing over and over. I also remember at one point he was talking about his and how they had came to be in Kirkcaldy. I can't remember specifically what he said. was in the house at this time and was shouting for my attention. The conversation in total

lasted between 15-20 minutes. At the end of the conversation he handed me a leaflet. I remember him telling me about the cost of their legal team and he was explaining to me about a number of fund raising activities.

I have today at my home address handed to Investigating Officer (IO) Kareen Pattenden, PIRC, the following item to which she attached a Production label and placed in a Production bag marked as indicated below:-
