#### WITNESS STATEMENT

I got up and looked out of the window. I saw a man going down to the ground with about 6 police officers around him, but I can't be sure of the exact number. It was just a split second that I saw him going to the ground. There were 2 or 3 batons lying in the road, definitely 2, might have been a third. The man kept making roaring noises and shouted something similar to "get off me".

The police officers were struggling, they were tying his legs up with yellow tape.

This yellow tape was round his ankles. I'm not sure if the man was lying on his front or his back as I couldn't see his head.

I didn't hear what police officers were saying but I could hear voices. At this time I was standing at my upstairs window looking down onto the footpath. The man was lying down next to the beige paving on the footpath at a crossing on Hayfield Road near this roundabout. I'm not sure how far this is but it's about 20 metres from my front door.

There was a police officer on the man's right hand side nearest to the roundabout. I saw this officer lean down to check if this man was still breathing as the man had gone quiet and wasn't shouting. He also looked like he was checking for a pulse, by this time my friend Hazel came through as I shouted her to come through from the back bedroom.

We then saw the police offices doing CPR, constantly on rounds of 15.

One of the officers came across to speak to my neighbour who ledieve is called Kevin.

The police officers were taking it in turns doing compressions. When the ambulance arrived, the ambulance officers took over. They were working on him on the ground. The police officers were still round watching the ambulance officers work.

The man was eventually taken away in the ambulance, when they moved him. I could see his arm and see that the man was a black man, with a white T-shirt. There were lots of police vehicles in the street, there were quite a few vehicles there when I first looked out of my window.

The roaring noise I heard was a man shouting and making the roaring noise.

When I was looking out of the window, the window was closed at all times.

I have also recorded some parts of this incident on my mobile phone.

When the man was taken into the ambulance I think his hands were tied together facing upwards.

I confirm this is a true and accurate account of events. I would also like to add that from looking out of the window I couldn't identify what each police officer was doing
