I am the above named person and I am a 43 year old female. I am a fully qualified General Practitioner and have been for about 4 months. I also work as a forensic medical examiner and have been so for about 10 months.

I have been a qualified doctor since 2008 and I also completed various post graduate training.

In my role as a FME I am often called out to Police Stations, mostly to examine persons who are within police custody. I also examine witnesses, or the victims of crime. On Sunday 3rd May 2015 I was contacted and requested to attend at Kirkcaldy Police Station to examine a number of police officers who had been

involved in a Police Incident. I duty attended at the station between 1545hours and 1740hours. I examined nine (9) police officers in total. These officers were both male and female, and were examined for any injuries, and general health. Although this was a physical examination, I would also note any mental distress as well.
