"Aye, that's what we're wondering noo because the ISIS attack and that on a female on Friday big boy."

This comment is in respect of a briefing I am 95% sure was given by the police in respect of a possible attack on a female officer by ISIS. I cannot recall how the briefing was given, whether it was an electronic briefing or a memo. I also cannot recall who gave this briefing or when it was given. I believe this particular briefing was roughly about the same time we were told to always be double crewed and not go about on our own.
