WITNESS STATEMENT

I have been asked about the text messages between myself and Zahid and in particular what the meaning of "getting on it" is. This means that I would only be sitting up for the boxing match and not sitting up for a long time having a good drink.

As I said previously, Zahid and Shek were fine when they came into the house. Shek had brought a bottle of Parrot Bay which I looked at and saw it was a liqueur at 19% proof. I thought Shek may have had a drink before arriving but he wasn't drunk.

When I was in the kitchen talking to Zahid it was really serious and he (Zahid) was
talking about his family problems. He mentioned to me that he had taken something
earlier and by that I thought he had taken MDMA.
I am not aware of any drugs having been taken by Shek or Zahid
in my house that morning.

Regarding Shek leaving after getting paranoid, I remember when we were all sitting in the living room Zahid had said to Shek that he was taking things the wrong way and spoke about a previous incident in another house where Shek had a similar paranoid situation. I asked Zahid about this later, but he didn't really give me any more details, of what had happened apart from him thinking (Shek) that people were taking the piss out of him because of his colour.

When Zahid phoned me after being attacked by Shek, he told me that he was in Fairisle Road. I drove down and he had moved to Glamis Road where I collected him. He was in a state of shock but didn't have any obvious injuries. He was shaking and traumatised by what had happened. He told me his head was really sore from being hit. Zahid had his car keys with him and so when I dropped him off at Arran Crescent he was able to get in to the car and drive away. I didn't see any damage to the Seat car at that time.

I have nothing further to add and I don't know anything about which drugs or steroids Shek has taken in the past.

I confirm that this is a true and accurate record of my involvement in the incident that took place on Sunday May 3rd 2015.
