I have already given a statement to the police about an incident involving a friend of my boyfriend. My boyfriend is Martyn Dick and his friend was Shek, who died on Sunday.

DSI Dodd has read the statement over to me and up until the point Martyn got home at quarter to four on Sunday morning 3rd May 2015 it is a true and accurate record.

Shek and Zahid arrived at the home at about 4am. Zahid drives a white saloon taxi type car. Shek brought a bottle of Parrot Bay alcohol and a mixer with him which was in a carton. Shek and Zahid seemed ok and not under the influence of anything. I sat on the couch and Shek sat on the armchair under the stairs. He put his drink on the

floor. We just talked about things in general. [REDACTED]
[REDACTED] Shek showed me a professional photoshoot of his baby [REDACTED], which he had on a mobile phone. During this time Martyn and Zahid were in the kitchen dealing with the food. Shek then stood up and went into the kitchen. I had paused the fight on the television at Round 8 and had put it on time lapse for the big fight. I sat in the living room alone for about 5 minutes before the three of them came back in. During this time Shek came back into the living room, said he was going to have a fag and rejoined the other two. [REDACTED]

The seating arrangement when we were all back in the living room was myself and Martyn on each end of the couch, Shek on the seat under the stairs and Zahid sitting on the chair nearest the fire.

The boxing was on in the background but we didn't really watch it and had conversations across the room. I'm used to having several conversations at the same time because of my job, but the others found it difficult, particularly Shek.

Shek started to get confused and mimicked something Zahid said about an apprenticeship. Martyn and myself found it quite funny. Zahid moved and sat in the middle of the couch so that we could talk ourselves and I think that Shek may have thought he'd been left out.

Shek then sat forward, clasping his hands, fidgeting and agitated and wasn't following the conversation. He became paranoid and I thought that he had maybe taken drugs. [REDACTED]

I was talking about a spray tan that I got for a wedding at the end of March and I said it was "shit". Shek suddenly said that "the MDMA was shit" or something similar to that. The atmosphere became uncomfortable and I thought about leaving and going upstairs to bed.

We started talking in general about an electrician called [REDACTED] [REDACTED] being a con man and my friend [REDACTED] being a nightmare. Shek again thought that we were talking about him and said that he wasn't a con man. There were no raised voices or anything, it remained calm. Zahid and Martyn tried to convince Shek that they were not talking about him, but it didn't register with him.

Suddenly Shek stood up and said "Sorry, I have come into your house to watch the fight and I have not offered you any money for it". I told him that we didn't want any money from him and only wanted him to feel happy and comfortable in my home. He made a sarcastic remark when I said this, put on his hoody and left the house by the back door from the kitchen. That was the last I saw him.

DSI Dodd has read the police statement over to me from this point and I can confirm that it is a true and accurate record.

I can confirm that this statement I have provided is a true and accurate record of what I observed on Sunday 3rd May 2015.
