About 0645 this morning (3/5/15) I received a phone call from Robson on the house phone. He was asking if I could pick him up to get a lift home. He told me to meet

him at the Templehall shops at Glamis Road, Kirkcaldy. I agreed to meet him about 20 minutes later to give me time to get dressed and travel through.

I drove my black Peugeot 107 registration through. I arrived at the shops as arranged but Robson wasn't there. I text him to say I was there, that is timed at 0658 on my phone.

Robson text back to say he was at the bus stop, I drove to the bus stop on Glamis Road and picked up Robson.

We drove down Glamis Road and turned left into Templehall Road with the intention of driving along Hayfield Road past the hospital and back to the house.

As we drove along Templehall Avenue I saw a male walking on the footpath on the left hand side, the male turned and walked towards the road just near to the last traffic calming before Hendry Road.

I wasn't sure if he was going to cross the road and he walked into the road and stopped in the middle of the lane I was driving on and started walking directly towards my car.

Just as we passed the male punched the side of the car. Robson said "I THINK HE'S GOT A KNIFE." I looked in the mirror and saw the male running after the car. I was concentrating on the road so I couldn't see if he did have anything in his hands.

I turned left at the mini roundabout and stopped just outside the Shell petrol station. I asked Robson to phone the police which he did from his mobile phone and he dialled 999. Robson told them what he saw, Robson wasn't sure of the streets in the area so passed the phone to me and I gave them the details.

After the call I looked in the mirror and saw the same male run across the road and out of sight into Hayfield Road area.

I turned the car around and drove to the junction at Hayfield Road and turned into the road and I saw the male again. I stopped at the bus stop just into the street and he was jumping in front of other vehicles including a taxi and a van.

I called the police again using Robsons's phone to let them know where he was. After this call I turned the car and continued home along Dunnikier Way.

The male I would describe as black African male muscular, late 20's early 30's, about 6'give or take certainly not a short guy, short hair, wearing a white t-shirt with a design across the chest area, black jeans or black trousers, I don't know about his shoes. He actually looked fairly well presented, clean shaven I think.

I would say he appeared to be maybe arguing about something, as he banged the car and chased it. I have never seen this man before so I have no idea why he was the way he was, it just seemed to be that we were there and he seemed to be looking for a confrontation by the way he was jumping in front of other cars and vehicles.

I have a dash cam on my car which records all the time. I have footage of the male approaching my car and also in the road in front of the other vehicles. I have viewed

the footage myself so it has recorded the incident. The footage is stored on an SD card which I have given to the police now referred to as

LABEL No. SD CARD FROM DASH CAM HARRY KOLBERG.

I didn't see the male with a weapon and I was busy concentrating on where he was and my driving.

After I left Hayfield Road I never saw the male again.

The footage reference number on the dash is number 283 which refers to the recording number stored on the card.

I confirm this is a true and accurate account.

The time stamp on the footage will be 1 hour ahead as I haven't changed it since the clocks changed so it would show 8 o'clock for actually being 7 o'clock.
