I would see him fairly regularly in the passing as he would be attending the gymnasium. He was always happy, smiling and really was a nice guy.

On Sat 2nd May 2015 I was nightshift				
and I finished on				
Sunday 3/5/15 at 06.00 am. I arrived home at 06.20am. The street was quiet and I				
went into my home. I saw my daughter Tegan's window open and asked if she was				
awake and I asked her to close her window. She did. In my home, I made a cup of				
tea. Pauline was sleeping and I went onto my computer				
about 0625/0630. Tegan came downstairs with her				
friend Amy Hutchison. Tegan said "Chris is fighting in garden". I				
did know their number but they stay				
Pauline and I had been robbed				
. I thought that Chris had caught				
someone trying to rob				
could assist Chris and by this time they were no longer in the garden and Chris was				
down by the lane to the right side of my home. I never saw the other guy at any				
point. When I reached Chris he was walking towards Crammond Gardens. I				
approached him and asked him if he had stopped someone from robbing				
and he replied "no man, no one's robbing no one". I asked if he was okay. He				
turned to face me. he was holding a knife which was a stainless steel blade with				

similar handle like the biggest one you would get in a kitchen block. He had the knife down the right side of body and was tapping it off his leg. He said "it's nothing, it's nothing". I said " if you get caught with that you're going to get done or someone's going to get hurt".

He didn't seem hyped up, didn't appear psychotic or drunk. I couldn't tell if he was under the influence of something but he definitely wasn't himself. Normally Chris would be all smiles and would chat as he always seemed happy but on this occasion I could see he was a bit vague and kept saying it was nothing, referring to the knife. I asked him to calm down and come back to my house for a cup of tea. I didn't this as I know he was a nice guy although I may not have been thinking right to have invited him. He said "no, no", I'm cool and he then walked away towards Crammond Gardens and away from his house. I walked back home. His house was in darkness. Pauline, Tegan and Amy were at my front door. I explained to Pauline what had happened and Pauline gave me a row for inviting Chris back to the house for tea. By this time it was just after 7am. I stayed in my home and was having a cup of tea in the kitchen. Pauline called me through to the living room and I saw a transit motor van which was white being driven off to the left of our house. I also saw a white Cavalier but could be wrong as to it's make drive away but I couldn't identify who was in the car or van. I went to bed about this time. It was about 7.30am. My wife had told me that Chris had come back to house and couldn't get in but this was before the van and car left. Comment I should have said that when the white van had arrived my wife Pauline and Tegan said a man, an Indian/Pakistani man had got out and drove away. Pauline said that that was the man who had been fighting earlier with Chris as Tegan had told her so.(not witnessed) When I woke up my daughter told me that the police had been outside Chris's house all day. When at work on the Sunday night, Pauline phone me and I learned that Chris had died. When I approached Chris he was wearing a navy top with a hood, dark jeans and dark trainers. He had his hood up. That morning it was raining but it daylight.
