[REDACTED] On Sunday the 3rd May I got picked up from my house by [REDACTED]. I can't remember what kind of car she drives I think its dark coloured, but I'm not sure. She picked me up at 0715. [REDACTED] was already in the car in the front passenger seat. I sat in the back of the car. On our way to work we were driving down Hendry Road just about to turn into Hayfield Road when we seen a man walking on the pavement of Hendry Road on the corner. He was heading towards Hayfield Road. He was a black male, around 5"9, he had short hair and muscly arms and he was wearing a white t-shirt with a coloured motif on the front and jeans. I noticed him at the time because it was pouring with rain and he didn't have a jacket on. He was walking as if

he was on a mission, he was really power walking. There is a path on the corner of Hendry Road which cuts across to Hayfield Road. The man was walking on the path, on his left there was some bushes and on his right hand side it was just grass. I didn't see him walking on Hendry Road but I got the impression he had come from that direction. As I was turning into Hayfield Road he was on my left hand side. Lisa turned around and said to me "Am I seeing things, is that a knife he's got?" I then looked and seen him holding the knife in his left hand, the hand that was furthest away from me. The blade looked as though it was about 12 inches long, by about 2-3 inches in depth. I would describe it as the type of knife that a butcher would use to cut meat.

We continued to drive past him and continue our journey [REDACTED]. I didn't see anyone else walking in the area at the time or any other cars. There wasn't any police officers present either. I didn't see the man again after that. Later on that day at work I heard he had been arrested and a police woman had been hurt. I didn't think anything else of it.
