and Dave didn't really say much back. As we drove away from him I asked Dave what the guy had said, he told me the guy said there was a man standing in the middle of the road with a knife and we should turn around. I don't remember what street it was but a couple of minutes after speaking to the guy in the car I seen the man with the knife walking in the middle of the road. He was about 50-60 metres away from me, he was a black guy, I can't really remember what he was wearing. It was possibly a t-shirt and trousers, he looked quite stocky. He had the knife in his left hand, it looked about twelve inches in length, like a carving knife. He looked quite menacing, he was walking as though he owned the place, full of bravado. We continued on our journey to our next job, we didn't get any closer to him. Shortly afterwards I seen one police vehicle with sirens on drive towards us and an ambulance. They were headed in the direction of the guy. I didn't see him again after this. I don't remember any other cars in the area at the time other than the one that stopped us. I didn't see any other pedestrians either.
