On Sunday 3rd May 2015, I was on a 0700 - 1600 hours duty within the Levenmouth Criminal Investigation Department. That day I was accompanied by DC Callum CLAYTON 245.

About 0745 hours, same date, DS DURSLEY made DC CLAYTON and I were made aware of an ongoing incident in the Kirkcaldy area, whereby a male was injured in relation to an altercation with the Police on Hayfield Road, Kirkcaldy.

DC CLAYTON and I made our way to Kirkcaldy area to liaise with colleagues.

WITNESS STATEMENT

About 0820 hours, same date, we attended Kirkcaldy Police Station whereby we were given a briefing about the incident.

About 0900 hours, same date, we were requested to attend at Collette Bell's address Arran Crescent, Kirkcaldy to carry out a check on the home owner. The call was about a female returning home and observing the rear door to the property was open and her partner was not within.

On arrival there was no answer at the dwelling as the informant was out to collect her child from her mothers.

About 0920 hours, same date, the initial informant re-attended and entry was gained. On speaking to her, Collette BELL, born [REDACTED] /1988 at [REDACTED] [REDACTED] Arran Crescent, Kirkcaldy, it was established her partner was a male named Sheku BEYOH.

About 1030 hours, after speaking with witness Collette BELL and liaising with DS DURSLEY it was established that the address at [REDACTED] Arran Crescent was to be secured and protected as a crime scene.

Witness Collette BELL had a 15 week old child with Sheku and was present during this time, along with her mother. The child required to be breast fed prior to leaving the dwelling, this being the reason for the time gap from arrival to securing the scene.

Witness Collette BELL was then conveyed to Kirkcaldy Police Station. At that time in the presence of DC MITCHELL I passed the death message to witness Collette BELL of her partner Sheku BEYOH. Following this, where in the presence of DC MITCHELL, I noted a statement from her on a major incident form.

About 1510 hours, same date, in my presence, DC MITCHELL contacted Sheku BEYOH's sister Kadi JOHNSON. At that time we passed the death message about her brother to her.

I took no further part in this enquiry.

I cannot identify accused.
