#### WITNESS STATEMENT

In my statement noted from myself by PIRC Investigator Kareen Pattenden on the 3 July 2015 I stated that I spoke to PIRC Investigator Keith Harrower at 0954 hours and that I told him that the deceased (Sheku Bayoh) had been in possession of a knife resulting in police batons and sprays being deployed.

Today (12.1.18) Investigator Sinclair has shown me a PIRC production

Production no. DSI Harrower operational notes - death of Sheku Bayoh

I have been informed that within these notes DSI Harrower has recorded having a conversation with myself at 1022 hours and that I said "male ran towards officer with a knife". I recall stating that to DSI Harrower. Colin Robson was the on call Detective Inspector that day and he provided me with numerous updates. It was Colin Robson who mentioned during one of the updates that Sheku Bayoh had ran towards the officers with a knife.

In relation to my statement where I have stated that I informed DSI Harrower of Sheku Bayoh running towards the officers with a knife at 0945 hours whereas DSI Harrower has recorded this conversation as being at 1022 hours. All I can say is that I had numerous conversations with DSI Harrower that morning and exactly when I told him that I cannot say.
