1. Terms of Reference – Gold Strategy (CS Garry McEwan)

To ensure the Scottish Police Service provides an effective and professional response to this incident at all stages,

Provide support, reassurance and timely information to the family, other persons involved in the incident and our own staff.

Provide reassurance to the community and public acknowledging the impact this incident may have had,

To return the community to normality as soon as reasonably practicable at the conclusion of this incident, and

Ensure the integrity, interest and reputation of the Police Service of Scotland and its staff is maintained and safeguarded.

Agreed that wording of terms of reference would be considered and amended for future meetings to provide terminology specific to circumstances of incident.

## 2. Factual Update – (Det Insp Robson)

Synopsis of events provided by DI Robson which included circumstances of initial calls from the public leading to the police response, verbal account of police engagement with the male (PS Maxwell). Thereafter the update on the injury to PC Short and subsequent locus protection measures and considerations with regards to the incident involving recording and

seizure of a knife believed to have been in possession of the male. The welfare of the officers concerned and identification of significant witnesses was also outlined.

The events relating to the deceased being conveyed to the hospital his treatment and subsequent PLE were outlined and thereafter the process in an effort to identify him.

The circumstances of the subsequent call from Collette Bell (deceased's partner) also summarised to provide details of an incident that occurred prior to police and involvement and which led to identification of male.

- CCTV Initial survey to be carried out
- House to House Established a strategy and identify parameters
- PF Fatalities David Green informed
- PIRC notification Informed by D.Supt Campbell
- CT considerations Raised by ACC and to be reviewed by NIB
- Investigative Structure SIO D.Supt Campbell and liaison with MIIT re support
- Police Officer statements Federation Reps providing advice to officers concerned regarding this matter
- Forensic Considerations Officers clothing and PPE to be taken possession of

She provided details of NOK, his sister who she did not have contact with her. Decision to be made re FLO deployment by MIIT officers.
