Karen and I discussed these events over that period of time. We discussed various incidents involving Alan and his behaviour and at one point Karen told me for the first time that Alan had wanted to join the British Nationalist Party (BNP) when he was sixteen. There was nothing out and out, up until that point that I ever felt that Alan was racist. There was a few comments, or off the cuff remarks, made by Alan over the early years which I took to be jovial and humorous. There was no malice or vindictiveness surrounding these comments but they were such as "that black bastard" or the "paki" jokes. I never challenged him, because I perceived it as a laugh. I didn't ever feel that he meant the comments. However, in my opinion the BNP is a political party with racial undertones about them, and as I became aware of Alan's early aspirations to join the BNP, I began to connect both that and the previous comments that I had witnessed him make.
